# Advocacy 101: Grievances, Arbitration, and Knowing Your Rights as an Employee

#### Facilitators: Dr. Kerr Fazzone and Gary Simmons

This course is intended to provide activists with an overview understanding of Grievances, Arbitrations, and Knowing Your Rights as unionists and develop an appreciation for the collective bargaining process. A primary focus of this course will be to address the Grievance Process and Knowing Your Rights as covered by the collective bargaining agreement and the importance and impact of arbitrations.

## **Bargaining Like a Team**

In this session, participants will work together with other members from their local to develop a bargaining blueprint, determine strategies, create a communication plan, and draft proposals. Participants should bring copies of their contract and be prepared to identify areas of need. Each participating local should send a group of members from their bargaining team including any chief negotiators, spokespersons, or crisis/communication team leaders.

Organizing focuses on power: who has it, who doesn't, and how to build enough of it to shift power dynamics and bring about change.
